Election Judges are the only contact the Board of Elections has with the public during voting hours. Therefore, Election Judges must be reliable, courteous, present a neat appearance, be able to follow procedure, and above all else, possess good judgement.

**Without Election Judges, it would be impossible to conduct an election.**

### QUALIFICATIONS:

Election judges **must:**

- Be registered to vote in Maryland
- Speak, read and write in English
- Be at least 16 by the General cycle
- Be able to work all day - 6am-9pm
- Set up the night before Election Day
- Be able to assist in lifting 30 lbs
- Have your own transportation

Election judges **cannot:**

- Be a candidate, campaign manager for a candidate, or a treasurer for a candidate or political party
- Engage in partisan or political activity while on duty

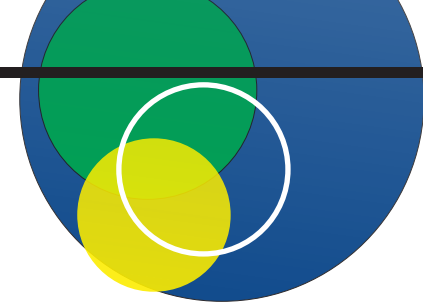

**TYPES OF ELECTION JUDGES:**

**Chief Judges**

Chief Judges are the managers of our polling locations.

**Same Day Registration (SDR) Judges**

These judges register people to vote at the polling locations on voting days.

**Check-In Judges**

These judges verify the voters' registration information.

**Provisional Judges**

These judges assist voters with the provisional process in the polling locations.

**Ballot Judges**

These judges distribute the ballots.

**Voting Judges**

These judges assist voters at the voting booth as well as the scanner.

**Alternate Judges**

These judges are placed on standby for the day. Usually you will be called to work by 10 am. You will be paid for the role you fill.

**Election Day Support Specialists (EDSS)**

Are you tech savvy? EDSS work part-time at our warehouse preparing for the election. Please contact us if you are interested in this position.

**COMPENSATION:**

This is a paid position and varies by job title as assigned by us. Completion of tax forms is required for payment.

**Training:** \$25/hour

**Chief Judges:** \$265

**SDR Judges:** \$225

**Provisional Judges:** \$225

**Check-In Judges:** \$200

**Ballot Judges:** \$200

**Voting Judges:** \$200

**Alternate Judges:** \$50 on standby, then paid for the job they fill

**MEET & GREETs:**

Get an overview of our election process and see if this is the right fit for both of us.

**TRAINING:**

Election Judges take **mandatory** training courses for the Primary and General Election. Failure to fulfill your assignment may result in denial of payment (unless excused by the Board of Elections).

**TERM OF OFFICE:**

Election Judges sign an oath to be available for both the Primary and General Election of that cycle. (Article 33, Section 10-203 of the Annotated Code of Maryland).
